- Name and gender of deceased
- Location of burial (Cemetery)

STEP 4

Applicant will then be directed to the Cemetery Keeper at the Cemetery which the deceased will be interred who would proceed to log the name and gender of the deceased in the Cemetery Register.

STEP 5

Cemetery Keeper will proceed to identify the available plot (no additional fee is applicable)

STEP 6

Applicant can now proceed to make Preparations for interment in the area identified by the Cemetery Keeper.

Did You Know?

- Burials within towns or villages other than in recognized burial places is prohibited.
- The Manchester Municipal
 Corporation's Burial within Towns'
 Limits Act gives the Corporation the
 power to define the limits of towns
 or villages within the parish within
 which burials can take place.
- It is unlawful to bury a dead body
 within the limits of a town or village,
 in any ground or place not being a
 parish burial ground or burial ground
 belonging to a place of worship or
 ground habitually used as a place of
 burial by the members of any sect
 or congregation, without license
 from the Local Board of Health.
- Any person or persons knowingly and willfully bury a body or assist in the burial of anybody in any ground or place in which burials are prohibited by the Act shall be brought before the Courts.

Requirements for Burial on Family Plot

- Proof of ownership (NB: Owner must be alive). (Registered/Common Law Title or owner listed on property tax roll or a probated Will). Owner will be required to show ID and sign Application Form.
- 2. Presentation of Death Certificate/Burial Order.
- 3. Certificate of payment of Property Taxes from the Tax Office (must be presented prior to processing of the request for burial).
- 4. If requirements 1 3 above are met, the applicant will then pay a (NON-REFUNDABLE) fee of \$2,500.00 at the Cashier at the Manchester Municipal Corporation and complete and sign the application form.
- 5. The Chief Public Health Inspector as well as an officer from The Roads & Works Department will visit the proposed burial site, inspect, and make recommendations for or against.
- 6. The applicant will then be informed of the decision, in writing.

DO NOT START GRAVE DIGGING UNTIL WRITTEN PERMISSION IS RECEIVED FROM THE CORPORATION/ PARISH COUNCIL.

How to acquire a Plot at one of the Corporations' approved Cemeteries.

STEP 1

Present the original Death
Certificate/Burial Order to the Cashier
at the Manchester Municipal Corporation
along with the applicable fees. (The
schedule of fees is printed overleaf)

STEP 2

Applicant will then be directed to the Roads and Works Department.

STEP 3

Superintendent of Roads & Works or his/her designate will verify the payment and log the following information:
