Drawings Required

- The drawing should be on white letter, legal or tabloid sheets (preferably done by draughting professional). It should include:
 - the site **location plan** which need not be to scale but should have sufficient detail to enable the site to be identified
 - the **site plan** with its position on the land (with distances from the road and from any existing signs in close proximity) or the building's relationship to adjoining properties
 - the **size** of the advertisement
 - sign details**—Side elevation, Cross section, Longitudinal section, Foundation plan, Foundation details, (fittings, colours, height above the ground, sign display content if known, projection from a building and the extent of the projection)

Owner's Consent

- Under the Regulations before consent is granted for an advertisement to be displayed the permission of the owner of the land or other person entitled to grant permission shall first be obtained.

Other Consents

- Consent under the Town and Country Planning (Control of Advertisements) Regulations 1978 does not relieve the applicant from obtaining any other Consent which may be necessary, e.g. Under the Building Act and Regulations made there under.
- No signs are to be erected before approval nor placed on light poles, in roundabouts or near directional signs.

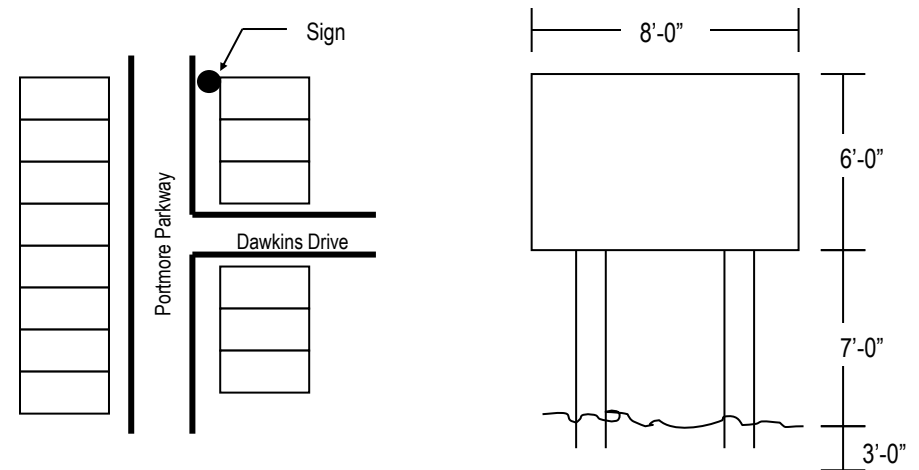
